Annex 1 - Mandatory conditions

- 1 Alcohol s19 Licensing Act 2003
 - (i) No supply of alcohol may be made under the Premises Licence at a time when there is no Designated Premises Supervisor in respect of the Premises Licence, or at a time when the Designated Premises Supervisor does not hold a Personal Licence or his Personal Licence is suspended, and
 - (ii) Every supply of alcohol under the Premises Licence must be made or authorised by a person who holds a Personal Licence.
- 2 Films s20 Licensing Act 2003

The admission of children (meaning persons aged under 18) to the exhibition of any film, must be restricted in accordance with the recommended age restrictions of the British Board of Film Classification (BBFC) or authority designated under Section 4 of the Video Recordings Act 1984.

Annex 2 - Conditions consistent with the Operating Schedule

- 1 From Sunday to Thursday, recorded music is only permitted after 23:00 if played at an ambient level.
- 2 On Friday and Saturday, recorded music is only permitted after 23:30 if played at an ambient level.
- The outdoor drinking area shall close at 23:00 each day and not open until 10:00 the following day. During the hours the outside drinking area is open the management or staff shall monitor activities to ensure that there is no disturbance caused to nearby residents.
- In order to avoid the creation of public nuisance, suitable signage must be prominently displayed at the exits requesting customers to leave quietly.
- 5 The disposal of waste is not permitted between the hours of 23:00 and 08:00 the following day.
- 6 Deliveries must not take place between the hours of 18:00 and 07:00 the following day.
- During events when live or recorded music is being played, the manager or an employee shall monitor noise levels at the boundary of the premises to ensure that residents of the area are not unreasonably disturbed.
- The licence holder or a designated person must maintain membership of the Pubwatch scheme.
- 9 Children under the age of 14 are not permitted on the premises after 23:00.
