Annex 1 - Mandatory conditions

There shall be no supply of alcohol under a premises license where there is no designated premises supervisor.

The supply of alcohol under a premises license is to be authorised by a person who holds a personal license.

All Films/Videos shown must have a BFFC Classification, which must be strictly adhered to at all times.

Annex 2 - Conditions consistent with the Operating Schedule

A) General – all four licensing objectives:

 No general conditions are proposed on the basis that there is no reason to suppose that variations will give rise to any general problem.

B) The Prevention of Crime and Disorder:

• There are no crime and disorder problems associated with these premises and no additional conditions are proposed.

C) Public Safety:

 There are no Public Safety Issues associated with these premises and no additional conditions are proposed.

D) The prevention of Public Nuisance:

 There are no Public Nuisance Issues associated with these premises and no additional conditions are proposed save that the use of the external area for drinking shall cease no later than 23:00.

E) The Protection of Children from Harm:

- Children under the age of 14 will not be permitted to remain in the premises after 21:00.
- If any film is shown that has not previously been broadcast before 20:00 hours on television, it will be subject to an appropriate age classification and children under the appropriate age will not be permitted in the premises when the film is shown.

Annex 3 - Conditions attached after a hearing by the licensing authority

Determined on: 27th September 2005

Decision:

Licence granted in the terms set out above, subject to the following conditions:

- 1. All regulated entertainment times are to conform with the times for the supply of alcohol, as set out above.
- 2. Children accompanied under the age of 14 will not be permitted to remain on the premises after 21:00 unless a Temporary Event Notice is in place.
- 3. Prominent, clear and legible notices will be displayed at all exits to the premises and in the car park requesting the public to respect the needs of local residents and to leave the premises and the area quietly.
