Mandatory Conditions:

Exhibition of Films:- Section 20

1. Where the film classification body is specified in the licence, admission of children must be restricted in accordance with any recommendation made by that body.
2. Where -
 - a) the film classification body is not specified in the licence, or
 - b) Arun District Council has notified the holder of the licence that this subsection applies to the film in question,admission of children must be restricted in accordance with any recommendation made by Arun District Council.

Supply of Alcohol:- Section 19

1. No supply of alcohol may be made under the premises licence
 - a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Conditions Consistent with the Operating Schedule:

General

The Prevention of Crime and Disorder

All staff members engaged or to be engaged in selling alcohol on the premises shall receive full training pertinent to the Licensing Act, specifically, in regard to age restricted sales, and the refusal of sales to persons believed to be under the influence of alcohol or drugs, before being permitted to sell alcohol. This training shall be documented and signed for by the employee and the DPS. The training records shall be made available for inspection, upon request, by the licensing authority and the police.

Refresher training in the form of staff meetings, at which the induction training is reinforced, shall take place as often as is necessary to ensure that every staff member attends such a meeting at least once every twelve weeks, and records of the meetings and the attendees, shall be maintained and made available for inspection, upon the request of the licensing authority and the police.

A written record of those authorised to make sales of alcohol shall be kept. This shall be endorsed by the DPS or other personal licence holder working at the premises with the date such authorisation commences. This shall be made available for inspection, upon request, by the licensing authority and the police.

The premises shall, at all times, maintain and operate a sales refusals log, and an incident log will be kept on the premises to record all refusals and incidents of crime or disorder. These shall be reviewed and signed by the Designated Premises Supervisor at intervals of no more than four weeks. Feedback shall be given to staff to ensure these are used on each occasion that a refusal or incident occurs at the premises. These records shall be made available for inspection, upon request, by the licensing authority and the police.

Digital CCTV and appropriate recording equipment will be installed, operated, and thereafter, maintained in accordance with Home Office guidelines relating to UK police requirements for a digital CCTV system (PSDB Publication Number 09/05), in the premises internally and externally to cover all public areas, including the entrance to the premises but excluding the toilet areas and shall be capable of operating in conditions of low light. The system shall be on and recording at all times the premises are open to the public, and will record and display dates and times. The system will be checked for faults and compliance on each and every occasion it is used, and any fault shall be reported to the police and rectified as soon as reasonably practicable.

CCTV footage will be stored for a minimum of 31 days. Facilities will be made available and staff trained to ensure that footage can be replayed on site for inspection by the police or other authorised officers, immediately, on request, and copies in a playable format provided as soon as reasonably practicable, but within 24 hours, at the request of Sussex Police, provided requests to view recordings and, or be provided with copies are compliant with data protection legislation.

To maintain membership of the local Pubwatch scheme or similar, as long as such a scheme is in operation.

Public Safety

A written risk assessment shall be undertaken and reviewed at least annually, or at the request of the police or licensing authority, within 48 hours of when such a request is made, to determine whether it is appropriate to deploy SIA registered door supervisors at the premises on any particular occasion and/or to determine whether polycarbonate/plastic, or shatterproof glass drinking vessels, shall be used in the premises. The recommendations of all such risk assessments shall be implemented and copies shall be retained for a minimum period of 6 months, and shall be made available for inspection, upon request, by the licensing authority and the police.

Any event taking place at the premises that is not within the scope of the normal day to day running of the pub shall be subject to a separate written risk assessment signed by the DPS and copied to the premises licence holder.

The Prevention of Public Nuisance

The external areas shall not be used for drinking after 23:00.

The Protection of Children from Harm

An age verification policy required by the mandatory condition shall specify that any person who appears to be under the age of 25, as opposed to 18, shall be required to produce proof of age in a form specified by the mandatory condition before being sold or supplied with alcohol.

Signage advertising the Challenge policy will be displayed in prominent locations at the entrance to the premises and behind the bar serveries.

INFORMATIVE:

The provision of live music between 8am and 11pm is not licensable (and so any conditions relating to the provision of Live Music do not apply) if;

the performance is unamplified or;

The performance is amplified and takes place to an audience of no more than 200 persons and;

The performance must take place when the premises are open and licensed for the sale or supply of alcohol for consumption on the premises.

The provision of plays and dance performances between 8am and 11pm to an audience of 500 persons or less is not licensable (any related conditions do not apply within the stipulated hours).

Indoor sporting events other than boxing or wrestling (with or without any martial arts) are not licensable between 8am and 11pm to an audience 1000 persons or less (any related conditions do not apply within the stipulated hours).
