Annex 1 - Mandatory Conditions

Supply of Alcohol (s19(2)&(3))

No supply of alcohol under the premises licence -

- (a) at a time when there is no designated premises supervisor, or
- (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence has been suspended.

Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

Exhibition of Films (s20(2))

Admission of children must be restricted in accordance with any recommendation by the British Board of Film Classification.

Special conditions (from the converted licence) apply to this premises licence (Para 6(8) schedule 8 Licensing Act 2003)

Annex 3 - Conditions attached after a Hearing by the Licensing Authority

- (1) Suitable signs shall be provided at each exit from the building requesting patrons to leave the area quietly.
- (2) All external doors and windows shall be kept closed between 2300hrs and 10.00am other than for access/egress, when events involving regulated entertainment are taking place.
- (3) The licensee or a nominated representative shall receive, record and respond to complaints throughout the duration of all events involving regulated entertainment
- (4) Prior to the carrying out of regulated entertainment on the premises there shall have been carried out a risk assessment that is kept available for inspection
 - (a) To identify whether or not security staff are needed
- (b) In the event that they are needed the number of staff necessary No regulated entertainment shall be carried out on the premises unless the number of security staff present is in accordance with the risk assessment. At all times that any licensable activity is taking place at the premises where security staff have been identified as being necessary the number of individuals to be employed and working there for the purposes of carrying out security activities shall be in accordance with the risk assessment.
- (5) Any power socket outlet and hence the power supply used with any portable appliance being used in connection with the provision of and performance of live music and/or other portable equipment for amplified music brought on to the premises by the provider of entertainment shall be connected via a residual current device (RCD) having a rating not exceeding 30 milli-amps. Should an RCD be considered inappropriate for use with a specific amplification system then the licensing authority must be informed of the reasons for this
