Annex 1 - Mandatory conditions

.1 Supply of alcohol:

- (1) No supply of alcohol may be made under the premises licence -
 - (a) at a time when there is no designated premises supervisor in respect of the premises licence, or
 - (b) at a time when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
 - (2) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

2. Exhibition of films:

- (1) Admission of children must be restricted in accordance with any recommendations made by Borough of Poole Licensing Authority.
- (2) In this section –

"Children" means person aged under 18.

3. Security:

(1) Where one or more individuals must be at the premises to carry out a security activity, each such individual must be licensed by the Security Industry Association.

Annex 2 - Conditions consistent with the operating Schedule

- 1. The premises shall be a member of the Pub Watch scheme, or similar, as long as such a scheme is in operation.
- 2. The maximum number of persons permitted on the premises at any one time, excluding staff and performers, shall not exceed ninety-nine (99)
- 3. The outside areas of the premises shall not be used after 23:00 hours
- 4. Children under the age of 14 shall not be permitted to remain on the premises after 23:00 hours
- 5. The premises shall have two (2) door staff on duty after 20:00 hours when musical entertainment in the form of live rock bands (or similar), discos and karaoke is provided.
